**Proposed Payment Rates

Medicaid Hospice**

**Effective October 1, 2011**

The Code of Federal Regulations at 42 CFR 418.306(c) requires hospice rates to be adjusted annually by a wage index that is published in the Federal Register. The Centers for Medicare and Medicaid Services determines the hospice rate amounts. The “Hospice Wage Index for Fiscal Year 2012” which specifies the adjusted hospice rates for federal fiscal year 2012 was published in the Federal Register on August 4, 2011. The federal fiscal year 2012 hospice rate adjustments are effective from October 1, 2011 through September 30, 2012.

A public rate hearing on the proposed rates will be held on October 27, 2011 at 9:00 a.m. in the Lone Star Conference Room of the Braker Center, Building H, at 11209 Metric Boulevard, Austin, Texas. This public hearing is being held in compliance with the provisions of Title 1 of the Texas Administrative Code (TAC) §355.105(g), which require a public hearing on proposed payment rates. The proposed rates are outlined in the attachment to this packet.
